To become a candidate for the position of Community-At-Large Member of the Board of Directors of the Court of the Great Northwest Imperial Empire I _____ agree to and represent the following:

1. I am least 21 years of age, and will provide verification of my age. Acceptable forms of identification include any Government-issued photo Identification with unexpired date.
2. I reside within the territorial limits of CGNIE and will provide verification (Rent receipt, utilities stubs etc.).
3. I have a work schedule that permits me to attend every Board of Directors meetings (regular meetings the last Tuesday monthly).
4. I am willing to give my true name and signature for the corporate directory, which is filed with the Board Secretary's office.
5. I will campaign, make appropriate public announcements and/or media releases of my candidacy as prescribed by the rules as enacted by the Board of Directors of CGNIE during the campaign period.
6. I will submit this form, completed and signed, along with a \$50.00 filing fee (non-refundable) on **Wednesday, March 11, 2020, at Faces Night Club, 2000 K St, Sacramento, CA 95811** between 6 p.m. - 7 p.m.
7. I understand that I am not required to be a current dues-paying member of CGNIE at the time of election, however if elected I agree to pay dues (\$3.00 per month or \$30.00 per annum throughout my tenure).
8. The Board of Directors of CGNIE will approve all election results. My seat is subject to confirmation by same.
9. I _____, wish to file for candidacy for one of the five Community-at-Large seats on the Board of Directors of CGNIE. I have read and fully understand all of the requirements, including Article 4, Section 1 of the bylaws (see below) to hold a seat on the Board of Directors.
 - A. I agree to attend all regularly scheduled Board of Directors meetings and any special meeting preceded by 72 hours notice. Three unexcused absences constitute immediate dismissal from the Board of Directors.
 - B. I also agree to attend and help at the annual celebrations created by CGNIE, Inc. Including: Coronation, Investitures, Installments.
 - C. In each quarter of CGNIE's fiscal year (May-July, August-October, November-January, February-April), I agree to attend and assist, as needed, at two court meetings and two Court sponsored functions. In each of these four quarters, I will also represent the organization (either with or for the reigning monarchs) at one out-of-town Coronation. I understand that failure to fulfill one quarters requirements constitutes immediate dismissal from the Board.
 - D. I understand that excused absences from the aforementioned include: personal illness, illness or death in one's family, or conflicting work schedule under the terms described in Section 3 above.
