2. That I reside within the territorial limits of CGNIE and will provide verification (Rent receipt, utilities stubs etc.).
3. That I am a current dues paying member of CGNIE, and will provide proof that I have been a timely dues paying member for the past 1 year prior to the application date. Per mandate of the Board of Directors, CGNIE, you may not retroactively pay any past due amount for membership dues.
4. That I am currently employed, and/or can provide visible means of support and a viable means of transportation.
5. That I have a work schedule flexible enough to travel and attend events throughout the Western United States; you must attend, in person, a minimum of eight (8) events during your reign.
6. That I have attended at least 5 court meetings in the previous year and participated in at least 4 charity fund raising events in the past year.
7. As a potential candidate I have or agree to acquire a working knowledge of CGNIE, and its By-Laws.
8. As a candidate, I must attend all court functions during the campaign; and attend in the proper attire of an aspirant to my respective titles.
9. In fairness to all qualified and accepted candidates for this election, no write-in candidates will be allowed to campaign or have their names submitted on the ballot.
10. That I agree to serve on the Board of Directors of CGNIE, give monthly imperial reports and attend board of reviews.
11. That I understand failure to comply with these stipulations and/or the By-Laws and policy motions of CGNIE, may be cause for disqualification of candidacy and if elected may result in loss of title and/or position.

That I agree to turn in this application, completed and signed, accompanied with a \$200 filing fee in cash, cashier's check or money order form, a 5 x 7 photograph of myself in the attire appropriate for the position for which I am seeking (black and white photo, digital scans acceptable in TIF or JPG format), and a letter of intent explaining why I seek this title and/or position on **Wednesday, March 11, 2020**, at the Faces Night Club 2000 K St, Sacramento, CA, 95811 between the hours of 5 p.m. and 6:30p.m., in the proper attire of an aspirant to my respective title.
13. That I will comply with any and all instructions from the Board of Directors of CGNIE, and/or their authorized agents/ designees regarding Board of Review process, Campaign Kickoff procedures and announcements of candidacy, and any other rules decreed by CGNIE.
14. All candidates must plan and host a candidacy fundraiser. Additional fundraising activities may be planned and hosted.
