Overview of Qualifications and Responsibilities

1. I am at least 21 years of age and can provide verification. Acceptable forms of identification include Government-issued photo identification with an un-expired date.
2. I understand the duration of a Reign is 12 months (April 2024 to April 2025)
3. I reside within the territorial limits of CGNIE and will provide verification (e.g., Rent receipt, utilities, stubs, etc.).
4. I am a current dues-paying member of CGNIE.
5. I am currently employed and/or can provide visible means of support and a viable means of transportation.
6. I have a work schedule flexible enough to travel and attend events throughout the Western United States; you must attend, in person, a minimum of Six (6 out-of-town events, supporting other courts, during your reign).
7. I have attended or participated in previous CGNIE charity fundraising events within the last 12 months.
8. As a potential candidate, I agree to acquire a working knowledge of CGNIE, its By-Laws, and Policies.
9. As a candidate, I must attend all court functions during the campaign and participate in the proper attire of an aspirant to my respective titles.
10. In fairness to all qualified and accepted candidates for this election, no write-in candidates will be allowed to campaign or have their names submitted on the ballot.
11. I agree to serve on the Board of Directors of CGNIE, give monthly imperial reports, and attend the board of reviews, as designated by the College of Sovereigns.
12. I understand failure to comply with these stipulations and the By-Laws and policy motions of CGNIE may cause disqualification of candidacy and, if elected, may result in loss of title and/or position.
13. I agree to turn in this application, completed and signed with the following
 - a. The \$200 filing fee can be paid with cash, cashier's check, money order, credit card, or Venmo (fee can be paid at board of review)
 - b. A 5 x 7 digital headshot in the attire appropriate for the position for which I am seeking (high-resolution digital format JPG or PNG with a minimum of 1024 x 768 pixels)
 - c. A letter of intent explaining why I seek this title and/or position
 - d. A written outline of proposed fundraisers for the year, along with the desired fundraising goal
 - e. Appear at the Board of Review in the proper attire of an aspirant to my respective title
 - f. All media and campaign materials should be sent to Media@cgnie.org for approval prior to posting and publishing
14. I will comply with all instructions from the Board of Directors of CGNIE and/or their authorized agents/ designees regarding the Board of the Review process, Campaign Kickoff procedures, and announcements of candidacy, and any other rules decreed by CGNIE.
15. I will campaign to make appropriate public announcements and/or media releases of my candidacy as prescribed by the Board of Directors of CGNIE. Complete *Campaign Guidelines* will be provided at application turn-in.
16. All candidates must plan and host at least one candidacy, fundraiser. Additional fundraising and/or candidate Meet N Greet activities may be arranged and hosted at the candidates' convenience but are strongly encouraged.
17. Elected monarchs understand their primary responsibilities include positively representing the organization to the community and the Imperial Court System. They are the organization's primary fundraiser and supported by their invested court, the 5M pageant title holders, and the CGNIE Board. These duties must be carried out with the highest level of dedication and determination to ensure the success of the organization. The CGNIE board oversees the monarchs, court, and other title holders. They manage and enforce the organization's policies and procedures and facilitate the business functions required by the California Attorney General and the California Secretary of State.
